My name is David Nicol and I am the Director of the Re-Engineering Assessment Practices project (REAP for short) led by the University of Strathclyde in Scotland. Over the last two years, the REAP project has had a major impact on assessment practices and educational strategy within three Scottish Higher Education institutions. We have redesigned assessments supported by technology in 22 modules involving over 6000 students and have examined the institutional implications of these changes.

Over 650 delegates in 44 different countries are joining us online to examine and discuss the role that assessment plays in developing responsible and autonomous learners.

The Conference case study library offers over 60 examples of innovative assessment approaches from different disciplines, contexts and countries. The authors of 16 of these case studies will be available during the conference to discuss their contributions and to answer questions from participants. There will also be panel sessions on assessment principles and a session on student participation in assessment design with students from both the US and the UK participating in the discussion. Experts from across the world will provide commentary on these sessions and will contribute to the discussions. For example, Derek Rowntree (UK), Steve Ehrmann (US), Terry Mayes (UK), Peter Kandlbinder (AUS) and Lewis Elton (UK).

For each session (keynotes, case studies and panel sessions) there will be a programmed hour of synchronous chat followed by discussion forums that will be open throughout the conference. This will provide you with opportunities for leisurely and thoughtful debate. All of the conference discussions and chat sessions will be captured and archived, creating a unique snapshot of current thinking on assessment and a valuable resource for future researchers.

This Online Conference offers a unique stage where leading edge experts, practitioners and enthusiasts from across the world can share their knowledge and practices. We are confident that this event will help reaffirm the pivotal role of assessment in our educational practices.
